2.2 2023 Data Review

- We did not meet our targets for the year which was 93%. We had some new students join us during the year which contributed to lower results due to factors such as English as a second language. All students have been included in the results.
- Writing was an area of focus that was identified which we will work on in 2024.
- Next year we will look to refine our ESOL programme. We will do some PD for staff to assist with meeting these needs.
- Maori achievement data is good.

2.3 Draft Budget - 2024

- Add additional capital expenditure. This would include funding for the Build & Play area, robotics for Waihanga and \$5k on Kapahaka uniforms. We will try to get a grant to cover Kapa Haka uniforms, however if we can't it will be already covered in the budget.
- We would like to add two board-funded 'Recruitment, Retention and Responsibility' units
 for 2024 to support Waihanga teachers. Increase funding by \$10k on the Teacher's
 salaries line to cover this cost. The Board discussed and approved the below budget line
 which are amended from the Draft Budget presented at the last meeting:
 - Kapahaka Uniform \$5000 (increase of \$5k)

- Waihanga/Creativity Centre \$20,000 (increase of \$8k)
- o Teacher Salaries \$140,000 (increase of \$10k)
- Shane is confident the Operations Grant will be higher than the MOE prediction based on our roll. The Board agreed to increase the Operations Grant line by \$10k
- The 2024 Budget was approved with the mentioned amendments.
